"Foucault: 40 años después"

[Monográfico coordinado por Mario Domínguez y David J. Domínguez]

Michel Foucault died in Paris on June 25, 1984, at the age of 57. Forty years after his death, his work continues to attract scholars and general public. The number of books, as well as doctoral theses, seminars and congresses focusing on his thought around the world is immense. Due to the posthumous publication of his lectures and unpublished material, Foucault's international impact has continued to grow over the last four decades. So much so that Foucault has even become today an inescapable academic reference for any research in the Humanities and Social Sciences.

He is an author who embodies risk beyond a necessity and who provokes the perennial restlessness of moving in the margins, in the articulations of the consolidated disciplines to achieve what he called a critical ontology of ourselves. His is a transgressive thought, of constant inventiveness. Sometimes he achieves a cartography of the seemingly impossible, and nevertheless inscribed in the critical tradition that fights against authority, heteronomy, but also against concealments, domination, and power. He showed another vision of the facts and taught us to observe the past in a radically different way through a considerable epistemological and methodological innovation. Moreover, because this renewal allowed him to study and at the same time describe the movement from the past to the present and from the present to the future. He presented a method of transition of which the present represents the center, where history is installed as a problem. And he does this always starting from his own time, recognizing himself in the genealogy of the present. He is not a mere comedian of transgression, of scandal or of the illusion of novelty. His studies are profound, meticulous, supported by an extensive and unusual documentation. This explains to a large extent the global impact of his work, as well as the growing worldwide proliferation of Foucauldian groups and networks, all of which justifies giving special significance to the upcoming commemoration of the fortieth anniversary of his death.

Thus, in line with the Foucault 40 years later World Congress, we have considered appropriate to dedicate a monograph to the topic of the reception of Foucault's work over the last four decades and the current impact of his thought. In particular, the aim is to offer an overview of the state of the art on the legacy of Foucault's work and its various uses. We are also interested in the fertility of his legacy in multiple disciplines, as well as in the intertwining of the concepts he coined, phenomena that underline the pertinence of his observations and his ways of interrogating the social order.
